NOTICE IS HEREBY GIVEN that on December 21, 2023, at 1:30 p.m., in Department 1 of the Superior Court of the State of California for the County of Santa Clara, located at 161 North First Street, San Jose, California 95113, the Honorable Sunil R. Kulkarni presiding, Petitioner and Plaintiff Miriam Green ("Petitioner"), on behalf of herself and all others similarly situated, will move and hereby does move this court for an award of attorneys' fees and reimbursement of expenses to Class Counsel, payment of settlement administration costs, and for a service award to Petitioner payable from the common settlement fund.

Specifically, Petitioner will request, and hereby does request, that the court enter an order (a) awarding Class Counsel attorneys' fees to be paid from the common fund in the amount of \$4,319,720.10, and (b) directing payment from the common settlement fund of \$14,557.65 to reimburse Class Counsel for costs incurred in litigating this class action, for total combined attorney's fees and costs equal to 25% of the common fund, which is \$4,334,277.75 Petitioner also moves for an award to Petitioner Miriam Green of \$7,500 as an incentive award. In total, between attorneys' fees, costs, incentive award, and notice/distribution costs Plaintiff seeks \$4,341,777.75, which is to be paid from the \$17,337,111 common settlement fund.
